Three training formats

In-company training courses

These safety training courses take place within your organisation (or at another location that you can determine) on a date specified by you. In-company training courses are recommended when four persons or more are to take part and are usually also less expensive. Travelling time is not involved and practical exercises are performed, if available, using the installations within your organisation. The student can, thus, for example, practice working safely in and around lifts. Many of the open training courses are also offered by Liftinstituut as in-company courses.
